Cheryl Brown went over the three handouts.

The first spreadsheet showed the expenditure balances as of 6/30/22. The state promised us \$4,265,352.00. Ms. Brown shared a quick glimpse of how the money was spent. She pointed out some negatives on the sheet, which are actually credits. She can't change the document, but what it probably means is that when we applied funding from a previous year, we deducted too much from this year.

The second spreadsheet showed what was spent last year. We received \$4,439,408.00 from the state, and we used \$2,914,717.44. This is the operating budget.

The last spreadsheet is the carryover for this year that we're applying to all the projects that were approved. Ms. Brown put \$228,639.25 in a contingency fund, and then allocated out all of the projects that were approved this year based off of the activity code numbers. This helped streamline our fiscal Concur process to one funding-org 121552-4102 .

5.1 Review Draft 2 - Student Equity Plan 2022-2025 (Brittanye, Roxanne)

After the previous SEA meeting, we received comments from our committee and other people who were consulted. We condensed some of the sections and

reduced the number of pages from about 90 to 52 pages. We also finished up a few of the sections that still needed to be done. This is the draft of the plan that we shared with the Academic Senate, and it is on their agenda for this Wednesday as an information item. Co-Chair Laurie Vasquez invited people to attend the Senate meeting on Wednesday.

Co-Chair Roxane Byrne gave a huge thank you to Co-Chair Brittanye Muschamp for the writing process, and also to the people who attended in the summer, in addition to the people who commented.
